**IT IS MUTUALLY AGREED:**

1. ADP agrees to build and install computer kiosks that will show local points of interest and local goods and services. ADP further agrees to maintain and service kiosks in the below listed locations.
2. Period of advertising shall be fifty-two weeks (52) from date of installation on kiosk.
3. ADP reserves the right to cancel this ad at any time it finds ad copy or advertiser unacceptable, with a full refund to advertiser for unused portion of advertising on a pro-rata basis.
4. All balances which remain unpaid after thirty (30) days from the date of invoice shall accrue a finance charge of 1 1/2% per month on the unpaid balance until paid in full, but in no event shall finance charge be in excess of the applicable legal maximum. For the collection of any unpaid balance money owed to ADP advertiser agrees to pay reasonable attorneys fees and court costs incurred in such collection.
5. Final acceptance and execution of this agreement shall be made by an ADP officer.
6. Copy changes may be made during the agreement period for an additional charge.
7. This agreement is non-cancelable by advertiser and advertiser acknowledges full and complete understanding of the terms contained herein.
8. Advertiser agrees that the liability of ADP, if any, for any omissions, mistakes, errors, and/or any defects in advertising shall in no case exceed the amount of advertising fees actually paid by advertiser to ADP.
9. Advertiser acknowledges that it has not relied upon any promise, statement or representation other than as contained herein and hereby acknowledges receipt of a copy of this agreement.
10. Advertiser agrees to pay to ADP monthly telephone long distance charges for reservation telephone service when applicable. This does not apply to local calls and toll free numbers.
